PROHIBITION ON CIRCULATION OF UNAUTHENTICATED NEWS



As per code of conduct for Stock Broker in SEBI (Stock Brokers and Sub-brokers) Regulations, 1992 and SEBI circular Cir/ISD/1/2011 dated March 23, 2011, all SEBI registered market intermediaries are required to have proper internal code of conduct to govern the conduct of its Employees. In view of same, Fortune Interfinance Ltd. implements code of conduct for communicating through various modes of communication. Employees/temporary staff/ voluntary workers are prohibited from:

- 1. Circulation of unauthenticated news related to various scrips in blogs/chat forums/e-mail etc.
- 2. Encouraging or circulating rumors or unverified information obtained from client, industry, any trade or any other sources without verification.
- 3. Forwarding any market related news received either in their official mail/personal mail/blog or in any other manner except after the same has been seen and approved by the compliance officer.

If an employee fails to do so, he/she shall be deemed to have violated the various provisions contained in SEBI Act/Rules Regulation etc. and shall be liable for actions.

Access to Blogs/Chat forums/Messenger sites etc. has been restricted .

Change in the Policy will be adopted as and when required by the company and is binding on all the Staff/Employees/and Directors of the Company.
